#### INTERNATIONAL TRADE ADMINISTRATION COMMISSION

#### SECOND PHASE OF THE REVIEW OF THE TARIFF STRUCTURE AND INVESTIGATION INTO THE POSSIBLE INTRODUCTION OF AN IMPORT SURVEILLANCE SYSTEM FOR STEEL PRODUCTS CLASSIFIABLE UNDER CHAPTERS 72, 73, 82, AND 83 OF THE CUSTOMS AND EXCISE ACT

On 20 August 2025, following the publication of its preliminary determinations on the first phase of the review, the Commission received additional submissions (109 written submissions) from interested parties on all the aspects of the investigation covered. The Commission finalised its work on the first phase of this review process and its recommendations on all tariff measures, as outlined in its Report No. 764, was implemented by SARS on 15 May 2026. Work is currently underway to implement the non-tariff measures that were simultaneously recommended on Report No. 764.

Also, additional requests were received from interested parties for: ***the addition of products on the list to be considered for possible duty increases; requests for additional rebate provisions to be created; and requests for more products to be considered for addition on the import control list.***

In light of the above, and following its preliminary investigations, the Commission published the additional areas on 21 November 2025 (corrected on 17 December 2025) and invited interested parties to submit comments on these additional areas.

##### **Additional requests following the implementation of ITAC Report No. 764 on 15 May 2026.**

The implementation of ITAC's report number 764 by SARS on 15 May 2026 also brought to light the need a further strengthening of both the tariff and rebate structure for all steel products. This will help align and optimize the entire tariff structure and rebate structure such that existing domestic manufacturing capacity is fully protected while at the same time ensuring availability of input material to downstream manufacturing industries in cases where certain product specifications are not made domestically.

In this regard, a number of requests have been received from interested parties for the creation of additional rebate provisions for the duty-free importation of certain grades of steel products not manufactured domestically and also for duty increases on additional product lines.

Following its preliminary investigations and wide-ranging industry consultations on all these additional areas, the Commission has decided to make the following preliminary determinations:

- 1. A preliminary determination that the rate of customs duties on all products outlined in Table 1 be increased to their respective WTO bound rates;*
- 2. A preliminary determination that rebate provisions be created for the duty-free importation of products as outlined in Table 2 and, where Schedule 2 duties apply, to extend the rebate provisions to also cater for such duties;*
- 3. A preliminary determination that all products listed in Table 3 be subjected to import permit controls in line with section 6 of ITA Act, Act No. 71 of 2002; and*
- 4. A preliminary determination to reject the proposed rebate quota of 85 000 tons on hot rolled coil for there-roller industry published on Table 2. The potential unintended consequences of such a rebate quota outweigh any potential benefits. Also, it is not the Commission's policy to recommend rebate provisions for products that are manufactured domestically with adequate manufacturing capacity.*
- 5. It is proposed that the Commission makes a preliminary determination to reject the proposed creation of the rebate provisions listed in Table 4 of Annexure A.*

It should be noted that the Commission has not yet made its final determination on any of the above and nothing in this notice should be construed as such. The final determination will only be made once the Commission has considered all comments on these "preliminary determinations".
