The objective of the roadshow is to ensure that there is sound understanding among the industry participants of the amendments and the implementation of the B-BBEE requirements for tooling and component manufacturers and the impact thereof as well as the recognition of contributions to the Transformation Fund by participants in the automotive value chain effective from 01 January 2025.
